WHAT

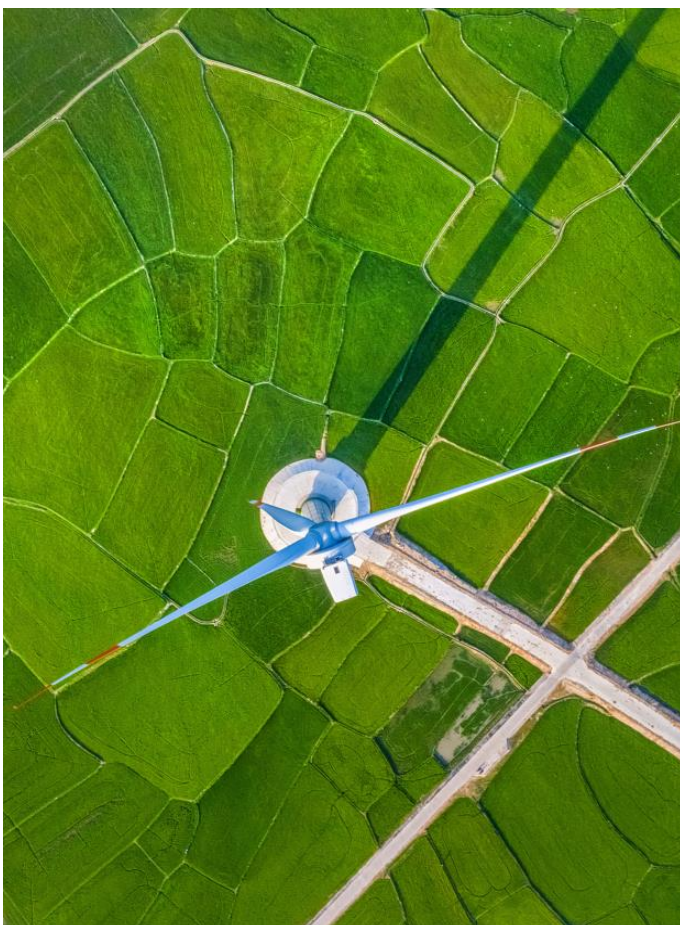
Skills for Transition is a **free training program** funded by UniCredit **to develop new skills** needed to **support the transition to sustainable, low-carbon economies**

WHOM

- To **people working** in some of the **industries most impacted by the green transition**
- To all those who wish to gain useful knowledge to meet the **challenges of the green transition**

WHY

- It enables the **acquisition of new knowledge** that is in high demand in the labor market
- It is **digital** and allows beneficiaries to **freely choose when taking training courses**
- It is **easily accessible** from all kinds of electronic devices
- It is **free**



Why we do it

SCENARIO

- **>70% of Companies⁽¹⁾** think that **digital and green transition** will **reshape** the way we do **business**
- **83m jobs** are projected to be **lost** and **69m** to be **created** in the next years, leading to a structural change in the labour market of **23% ⁽¹⁾** of the total
- the share of “**green talent**” in the international workforce **has grown by only 12 percent**, while the **share of ads requiring** at least **one of these skills increased by as much as 22.4 percent⁽²⁾**



WHERE JOB MARKET IS GOING

- **TRANSITION TO GREEN**
Professionals shifting to so-called “green” jobs, that is, those related to the green transition by strengthening skills functional to the transition
- **GREEN TRANSFORMATION OF EXISTING JOBS**
Existing jobs will evolve, incorporating green skills in increasingly profound and impactful ways

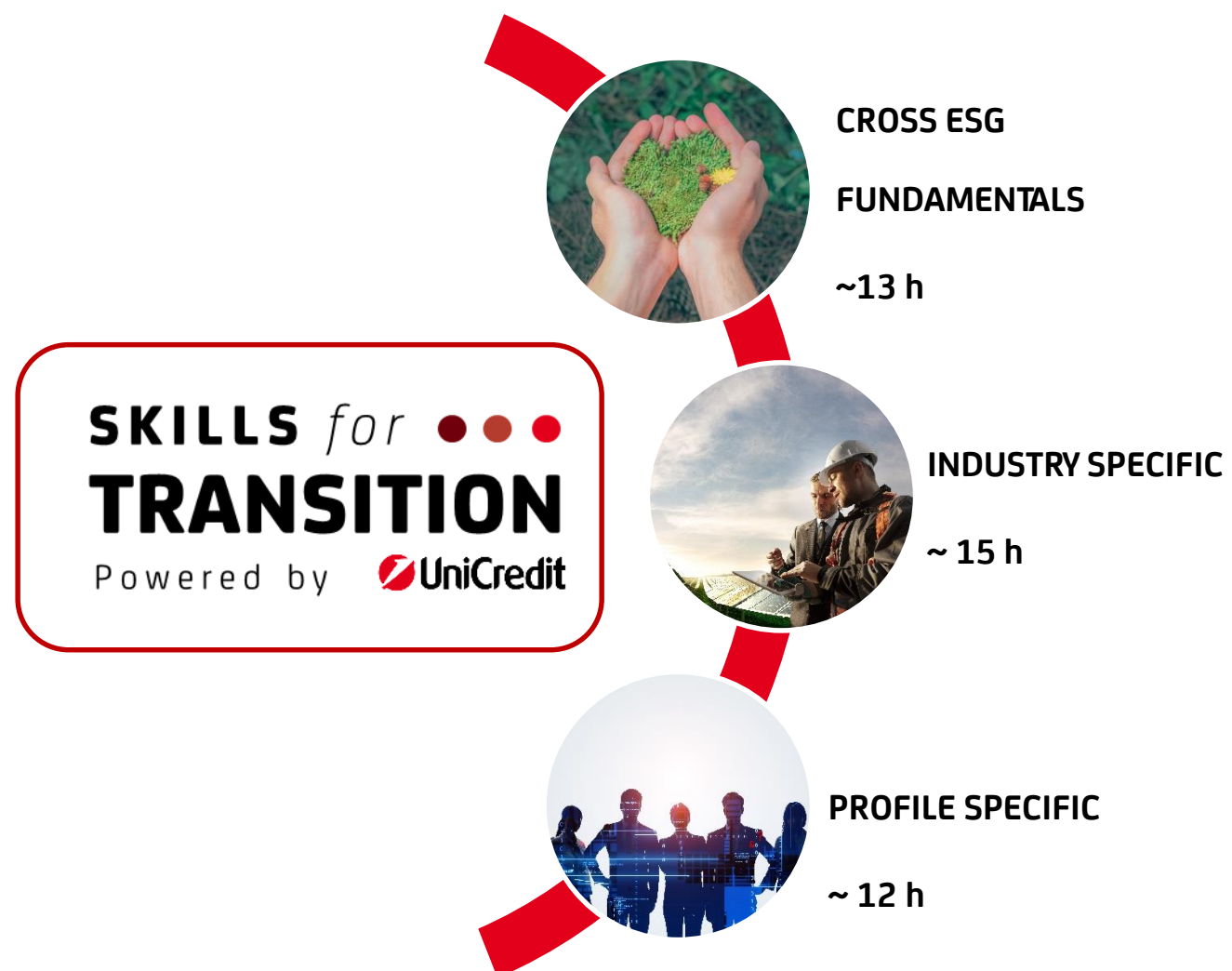
Education offering for Clients' employees

The digital offer consists of

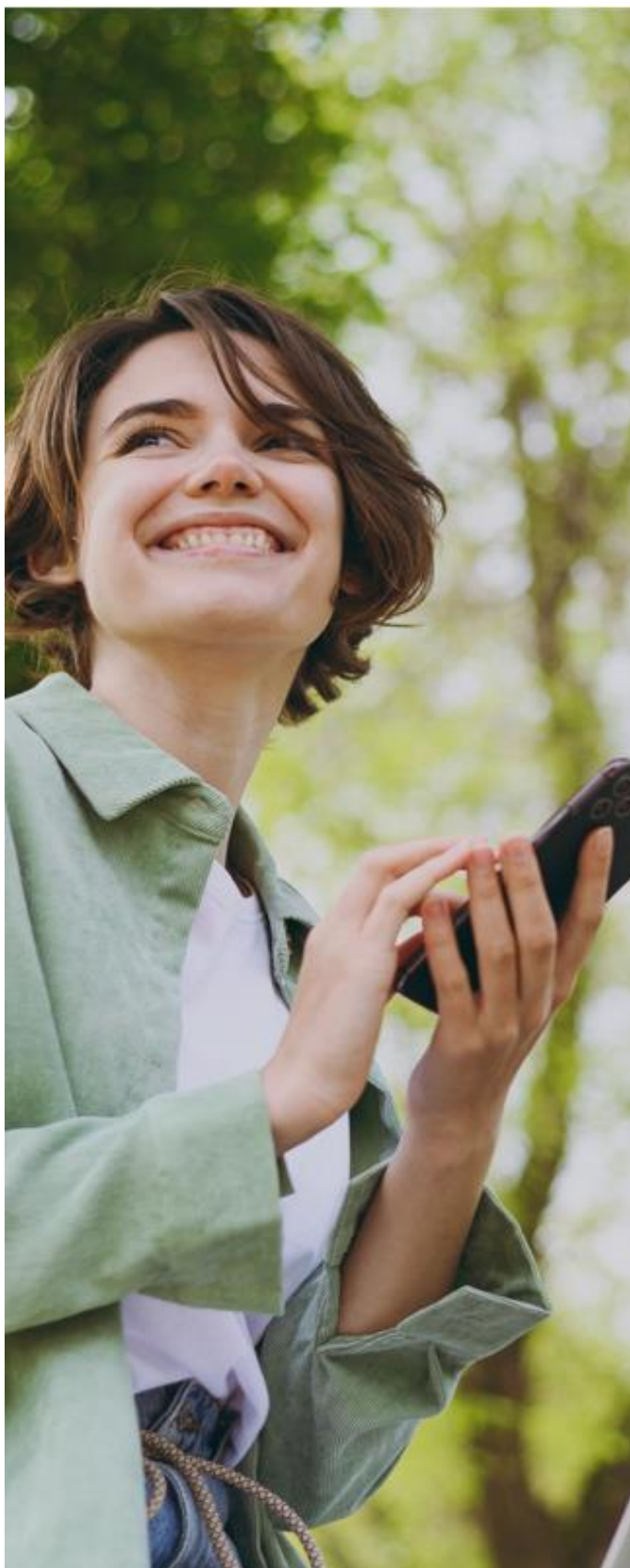
- a **basic course Cross ESG fundamental** suitable for any type of company

FORMAT OF EACH COURSE

- INTRODUCTION**
Introductory questions and short intro to get into the topics and gain an initial overview of the contents to be covered
- WEBINAR**
Training session to be delivered via webinar based on contents drafted by professors and/or experts in the field with few intermediate questions to assess learning step-by-step
- HANDOUTS**
Materials to summarize topics covered and/or scientific papers to deepen them, the latter depending on the topics
- FINAL TEST**
Assessment of the competences developed during training course
