- 1. The client pays a monthly fee for the service and maintenance of the plan. For the products and services included in the plan, no other fees/commissions, specified in the Tariff, are collected.
- 2. A newly opened account or an existing current account can be included in the plan.
- 3. The Private plan includes a high-end debit card-newly issued or already issued one.
- 4. The Private plan includes a high-end credit card-newly issued, If the client is eligible, according to the Bank's Lending Rules.
- 5. Fast transfers at customer's request for amounts under BGN 100 000 (equivalent in EUR) are not included in the plan. Fast transfers are executed with same day value in real time.
- 6. The Bank informs its clients about additional promotional terms, related to the use of Private plan, on the Bank's website. The plan is applicable for clients within Private banking.

The Bank has the right to change the products and services, included in the plan, as well as the amount of the fees due for the plan, with a change in the Bank's Tariff for the fees and commissions for individuals.
